#### <u>Health system transformation in 2020 and beyond: Reshaping</u> policies, practices, and service delivery in SUD treatment

This year has fueled a large shift in how SUD treatment is provided, accessed, and paid for - from the shift to virtual appointments, an uptick in telemedicine prescribing (notably, increased prescribing of buprenorphine), and insurance companies, including Medicaid, allowing billing for telehealth visits. As patients and providers alike settle into, and become accustomed to, more medical appointments taking place virtually, the rapid expansion of telehealth use is a prime example of redefining health system innovation moving forward.

Within a matter of months, SUD treatment services, providers, patients, and payers learned to adapt to this new healthcare landscape during the pandemic. Our Center is eager to further explore, evaluate, and contribute to SUD treatment system innovation through newly-funded studies about Medicaid managed care plans' opioid treatment policies, telemedicine and SUD service delivery expansion.

## Center Spotlight

#### Maureen Stewart receives NIDA R01 grant to study Medicaid health plan policies and opioid addiction treatment quality



Center researcher Maureen Stewart and colleagues <u>received an</u> <u>R01 grant from NIDA to study opioid addiction treatment offered</u> <u>through Medicaid Health Plans</u>. This study will identify and examine Medicaid plan policies and innovative strategies that may influence access to and quality of opioid treatment. Dr. Stewart hopes state Medicaid directors and Medicaid health plans could leverage findings to implement policies associated with better outcomes for patients.

# Constance Horgan appointed Co-Director of the Schneider Institutes of Health Policy and Research



# Center Researchers receive NIH supplements focused on service delivery expansion



Sharon Reif and colleagues received a supplement to NIDA

R01DA051067 (Hub and Spoke Opioid Treatment Networks: 2nd Generation Approaches to Improve Medication Treatment for OUD) to expand analyses to better understand co-occurring conditions of mental health disorders, alcohol use disorders, and/or other substance use disorders among people with OUD.

#### Haiden Huskamp and

colleagues received a supplement to NIDA R01DA048533 (Telemedicine for Treatment of Opioid Use Disorder) to design and field a survey of clinicians who provide care for opioid use disorder on their experiences with telemedicine during the COVID-19 pandemic.



# New Systematic Review explores association of APMs with MH/SUD service delivery and outcomes

# Network Open.

A recent publication in JAMA Network Open, <u>Association of</u> <u>Alternative Payment and Delivery Models With Outcomes for Mental</u> <u>Health and Substance Use Disorders: A Systematic</u> <u>Review</u>, evaluates and summarizes the implementation of existing alternative payment and delivery models (APMs) in mental health/substance use disorder (MH/SUD) treatment. Co-written by

Center researcher Alisa Busch, the systematic review identifies the association between APMs and improvements MH/SUD care quality, as well as reductions in service use spending on MH/SUD care. The authors also highlight the need for further research to identify successful program components and better elucidate the association between APMs and improved MH/SUD clinical outcomes.
